ARCHITECTURAL ADDENDUM NO. 2

The qualified Bidders shall acknowledge in writing on his/her Bid Form/Proposal the receipt of this Addendum.

This **Addendum No. 2** shall become a part of the **Bid Documents** (Drawings & Specifications) for this project and shall be integrated into the final **Contract Documents** to complete the Work. When the Architect issues an Addendum, it is the Bidder's responsibility to copy and insert it into the Bid Documents they have obtained from the Architect's office. It shall also be the responsibility of the Bidder to confirm that any subcontractor bidders, materials/suppliers bidders, etc. have received the addendum and acknowledge the receipt of any Addenda before acceptance by the General Contractor.

This Architectural Addendum contains TWO (2) items, and they are as follows:

ITEM NO. 1: In lieu of removing the Built-up Roofing System on the south section of the Civic Center building as previously indicated, the base bid should include removing all the loose gravel, and then installing the new recover board and TPO roofing system as specified over the top of the existing Built-up Roofing System.

ITEM NO. 2: Provide an alternate add price to completely remove the Built-up Roofing System and existing rigid insulation on the south section of the Civic Center building, and then installing new R-20 min. 1/4" per foot tapered rigid XPS insulation with the new recover board and TPO roofing system over top as specified.
