ORDINANCE NO. 1402

AN ORDINANCE AMENDING THAT CERTAIN ORDINANCE ENTITLED, "AN ORDINANCE ESTABLISHING CHARGES AND RATES FOR THE USE AND SERVICE OF THE COMBINED WATERWORKS AND SEWERAGE SYSTEM OF THE VILLAGE OF ORLAND PARK, COOK COUNTY, ILLINOIS, AND PROVIDING FOR THE REGULATION AND OPERATION OF SAID COMBINED WATERWORKS AND SEWERAGE SYSTEM," BEING ORDINANCE NO. 233. ADOPTED MARCH 13, 1961, AND APPROVED MARCH 13, 1961, AS AMENDED

BE IT ORDAINED by the President and Board of Trustees of the Village of Orland Park, Cook County, Illinois, as follows:

SECTION 1

AMENDMENT. That Section 1 of that certain ordinance entitled "An Ordinance Establishing Charges and Rates For the Use and Service of the Combined Waterworks and Sewerage System of the Village of Orland Park, Cook County, Illinois, and Providing for the Regulation and operation of Said Combined Waterworks and Sewerage System," being Ordinance No. 233, adopted March 13, 1961 and approved March 13, 1961, as amended, be amended to read as follows:

Section 1.A. That there shall be and there are hereby established charges and rates for the use of and for the service supplied by the combined waterworks and sewerage system of the Village of Orland Park, Cook County, Illinois, where the premises to which such service and use is furnished is located within the corporate limits of the Village of Orland Park, which said use and service for water shall be metered and the bi-monthly charge for water and sewer service shall be as follows:

1. WATER CHARGES AND RATES - BI-MONTHLY - BILLING PER UNIT

Service Charge - bi-monthly \$6.70
Water supplied - \$1.79 per each 1,000 gallons or fraction thereof.
Penalty: - 10% if not paid by due date of bill.

2. SEWER CHARGES AND RATES - BI-MONTHLY - BILLING PER UNIT

\$1.34 per each 1,000 gallons or fraction thereof of water supplied;
For Sewer Service only - non-metered \$13.50
For Sewer Service only - metered flow - \$1.34 per each 1,000 gallons, or fraction thereof.
Penalty: 10% if not paid by due date of bill.

Section 1.B. That there shall be and there are hereby established charges and rates for the use of and for the service supplied by the combined waterworks and sewerage system of the Village of Orland Park, Illinois, where the premises to which such service and use is furnished is located outside the corporate limits of the Village of Orland Park, which said use and service for water shall be metered and the bi-monthly charge for water and sewer service shall be as follows:

1. WATER CHARGES AND RATES - BI-MONTHLY - BILLING PER UNIT

Service Charge - bi-monthly: \$6.70

Water supplied - \$3.24 per each 1,000 gallons or fraction thereof.

Penalty: 10% if not paid by due date of bill.

2. SEWER CHARGES AND RATES - BI-MONTHLY - BILLING PER UNIT

\$.43 per each 1,000 gallons or fraction thereof of water supplied

For Sewer Service only - non metered - \$15.30

For Sewer Service only - metered flow - \$.43 per each 1,000 gallons or fraction thereof.

Penalty: 10% if not paid by due date of bill.

Section 1.C. A unit, for the purposes of this Section shall be a residential dwelling unit, an industrial or business establishment, public building, fraternal, eleemosynary or religious institution.

In any instances where water is supplied through one meter to more than one unit, the charges for the foregoing services shall be calculated as follows: The number of gallons of water metered shall be divided by the number of units and a separate calculation made for each unit.

Section 1.D. Adjustment of Rates. The Water and Sewer charges and rates herein in this Section set forth shall be adjusted from time to time as follows:

- (a) Any increase or decrease in the charges made by the City of Chicago, Illinois and/or by the Village of Oak Lawn, Illinois for water supplied shall be directly factored into the rates effective on the first day of the month following such changes.
- (b) Any increase or decrease in the charges made for electrical energy other than the adjustment for summer and winter usage shall be directly factored into the rates effective on the first day of the month following such change in electrical energy charges.

(c) Personal services, contractual services, (excluding purchased water and electricity) commodities and departmental cost transfers shall be factored into said rates on May 1st of each year, based on the Annual Budget for the fiscal year commencing on said date, passed by the Board of Trustees of the Village of Orland Park, Illinois.

Section 1.E. Billing Errors. An error in water and/or sewer charge billing shall not constitute waiver of claim for adjustment.

SECTION 2

EFFECTIVE DATE. The rates and charges herein established shall be in full force and effect and be applicable to all billings on and after February 1, 1985.

This ordinance shall become and be effective immediately upon its passage, approval and publication in the manner provided by law. It is ordered that publication of this ordinance be made by duplicating thereof in pamphlet form, said pamphlets to be deposited in the office of the Village Clerk of the Village of Orland Park, for general distribution.

SECTION 3

On the first day of February, 1985, all ordinances in conflict with the provisions hereof are hereby repealed insofar as they conflict herewith.
